## First Aid

**If Swallowed:** Do not induce vomiting. Give several glasses of water. Never give anything to an unconscious person orally. Seek immediate medical attention. Call a poison center or doctor/physician if you feel unwell.

## General Information

K-Klean is an effective cleaner for metal, fiberglass and plastic spray systems.

K-Klean aids in the removal of dirt, grime, grease, chemical and fertilizer residues from tanks and equipment.

K-Klean helps eliminate rust and scale and keeps costly equipment in ready-to-use condition.

## Directions For Use

**For large volume sprayers, and for tanks or sprayers not equipped with hand gun or hose:** K-Klean is effective at dilution rates of up to 1:100 (1 quart:100 gallons of water).

Adjust the dilution rate as needed for individual conditions. Circulate treated solution throughout the entire spray system for 5 to 10 minutes.

Use a high-pressure sprayer or hose to rinse all interior areas and tank walls. Purge hoses, spray lines and nozzles for at least one minute. After cleaning, drain system and rinse tanks and spray areas.

## Special Precautions

The use of K-Klean or other tank cleaners does not guarantee the removal of all residues. Some pesticides like 2,4-D and dicamba, may leave persistent or hard to remove residues. In order to ensure that all residues have been removed, apply a sample of the rinse water to sensitive plants (tomato, cotton, ornamentals, etc.) and after sufficient time, observe for wilting or severe stress. If stress occurs, repeat cleaning process and retest as above.
