Directions For Use

Injection Application: Inject HYDRO-WET INJECTABLE at a rate of 12 to 24 fluid ounces (360 ml to 720 ml) per acre (0.5 hectare) monthly, or as needed throughout the growing season.

For More Difficult Areas: HYDRO-WET INJECTABLE may be injected up to 48 fluid ounces (1,440 ml) per acre (0.5 hectare).

Conventional Sprayers: Apply 3/4 to 1 fluid ounces (22.5 ml to 30 ml), diluted in 1 gallon (4 litres) of water spray, per 1,000 square feet (100 square metres) of turf area. Apply monthly throughout the growing season.

Tank Mixing

Add 12 to 32 fluid ounces (360 ml to 960 ml) of HYDRO-WET INJECTABLE per 100 gallons (378.5 litres).
