First Aid

Directions For Use—Application Guidelines

Use **H2O MAXIMIZER** in a scheduled water management program throughout the growing season to improve irrigation efficiency resulting in shorter irrigation cycles while maintaining turf quality.

Turf Spray Applications: For best results on highly maintained turf such as golf greens or sports fields, apply 10 fluid ounces (300 ml) of **H2O MAXIMIZER** diluted in 1 to 2 gallons (4 to 8 litres) of water per 1,000 square feet (100 square metres) monthly.

For Irrigation Injection or Large Area Application: Inject 16 to 24 fluid ounces (480 to 720 ml) per acre (0.5 hectare) on a monthly basis throughout the growing season.

For Conventional Tank Mix Spray Applications on Fairways or Commercial Lawns: Mix 30 fluid ounces (900 ml) of **H2O MAXIMIZER** diluted in 40 gallons (150 litres) of water per acre (0.5 hectare). Reapply monthly or as needed throughout the growing season.

New Seedlings – Stand Establishment: **H2O MAXIMIZER** may be applied with initial watering cycle following a new turf seeding to enhance soil moisture and improve water infiltration. Use at a rate of 5 to 10 fluid ounces (150 to 300 ml) diluted in 3 gallons (12 litres) of water, per 1,000 square feet (100 square metres).

Soil Media Applications: For enhanced hydration of soil, peat or bark media use 5 fluid ounces (150 ml) of **H2O MAXIMIZER** diluted in 2 gallons (8 litres) of water applied to 1 cubic yard (0.75 cubic metres) of media. Add **H2O MAXIMIZER** to water and stir contents.

For Difficult to Wet Media: Use 10 fluid ounces (300 ml) diluted in 2 gallons (8 litres) of water applied per cubic yard (0.75 cubic metres).
